1. Basis of Preparation of Consolidated Financial Statements

The accompanying consolidated financial statements of Mitsubishi Tanabe Pharma Corporation (the "Company") and its consolidated subsidiaries occilectively, the "Group") have been prepared in accordance with the provisions set forth in the Corporation Law of Japan and the Financial Instruments and Exchange Law of Japan and its related accounting regulations, and in conformity with accounting principles generally accepted in Japan ("Japanese GAAP"), which are different in certain respects as to the application and disclosure requirements of International Financial Reporting Standards.

The accompanying consolidated financial statements have been compiled from the consolidated financial statements prepared by the Company as required by the Financial instruments and Exchange Law of Japan. In preparing the accompanying consolidated financial statements, certain reclassifications and rearrangements have been made to present them in a form which is familiar to readers outside Japan. In addition, the notes to the

accompanying connelidated financial statements include information which is not required under accounting principles generally accepted in Japan but is presented freeven as additional information.

Certain reclassifications of previously reported amounts have been made to conform the consolidated financial statements for the year ended March 3012 to the 2013 presentation. Such reclassifications had no effect on consolidated net income or net assets.

The translation of the Japanese yen amounts into U.S. dollars is included solely for the convenience of readers outside Japan, using the prevailing exchange rate at March 31, 2013, which was V94.05 to U.S.\$1. The approximate rate of exchange prevailing at May 31, 2013 was V101.18 to U.S.\$1. This translation of convenience should not be construed as a representation that the Japanese yen amounts have been, could have been, or could not the future be, convenienced into U.S. dollars at this or any other rate of exchange.

2. Summary of Significant Accounting Policies

(1) Principles of Consolidation

The accompanying consolidated financial statements include the accounts of the Company and its 28 significant consolidated subsidiaries for the year ended March 31, 2013.

Two affiliates including API Corporation are accounted for by the equity method. Tarvative Sergaku Malaysia, an uncorrectidated subsidiary, and Artienta Yoshstomi, Ltd., an affiliated company, are not accounted for by the equity method because the net income and retained earnings of these companies, are inspendicant.

The Company sold its entire shareholdings in Choseldo Pharmaceutical Co., Ltd. on October 30, 2012. As a result, Choseldo Pharmaceutical Co., Ltd. and its subsidiary, Hostelmu Pharmaceutical Co., Ltd. were excluded from the scope of equity-method.

Among consolidated subsidiaries, Tranjin Tanabe Seiyaku Co., Ltd. and 5 other subsidiaries have fiscal years ending on December 31. Their temporary financial statements based on a provisional settlement of accounts as of March 31, are used for preparing the consolidated financial statements. However, the classing dates of the other consolidated subsidiaries are the same as the consolidated closing date.

6Additional informations

For better comparability and disclosure of consolidated operating results, certain consolidated subsidiaries changed their fiscal year ends as follows: (a) Changes of fiscal year end

Mitsubishi Tanabe Pharma Korea Co., Ltd. and 12 other subsidiaries changed their fiscal year ends from December 31 to March 31.

(b) Implementation of provisional settlement of accounts.

Tiamjin Tanabe Seyaku Co., Ltd. and 5 other subsidiaries that have a fiscal year end of December 31 prepared temporary financial statements based on a provisional settlement of accounts as of March 31.

As a result, the concolidated financial statements are prepared based on the statements of income for fifteen-month focal periods from January 1, 2012 to March 31, 2013 of 13 suboiduries that changed their fiscal year ends and 6 suboiduries that changed their fiscal year.

Goodwill resulting from the difference between the cost and underlying net equity of investments in constituted subsidiaries and affiliates accounted for by the equity method is deferred and amortized using the straight-line method over a period of fifteen years.

(2) Foreign Currency Transactions

All momentary receivables and payables demonstrated in foreign currencies are translated into yen at the rates of exchange in effect at the balance sheet date and gain or loss on each translation is credited or charged to income.

The balance sheet accounts of the overseas consolidated subsidiaries are translated into yer at the rates of exchange in effect at the balance sheet date, except that the components of net assets excluding minorists are translated at their historical exchange rates. Revenue and expense accounts are translated at their historical exchange rates of exchange in effect during the year. Adjustments resulting from translating foreign currency financial statements are not included in the determination of net income and are presented as translation adjustments and minority interests in the accompanying consolidated balance sheets.

(30 Cash and Cash Equivalents

In preparing the consolidated statement of cash flows, cash on hand, readlyavailable deposits and short-term highly liquid investments with maturities, not exceeding three months at the time of punchase are considered to be cash and cash equivalents.

(4) Allowance for Doubtful Receivables

The allowance for doubtful receivables is provided to cover possible losses on collection. With respect to normal trude accounts receivable, it is stated at an amount based on the actual rate of historical based debrts, and for certain doubtful receivables, the uncollectible amount has been individually estimated.

(5) Marketable Securities and Investments in Securities

Marketable securities and investments in securities are classified into one of the following categories based on the intent of holiding, resulting in different measurements of and method of accounting for changes in fair value. Netd-to-maturity debt securities are stated at anomalied cost. Assistable for-sale securities with available market value are stated at market value. Unrealized holding gains, and unrealized holding losses on these securities are reported, set of applicable income taxes, as a separate component of accumulated other comprehensive income flood.
