- Short-dated (normally overnight to 7 days) money market instrument
 - repo's and reverse repo's
- Can use Treasury bills and Treasury bonds as securities
- Used extensively by central banks and/or debt management units to manage liquidity
- Preferred to issuance/buyback of Treasury bills
