- Intimate association must be secured from undue intrusion (p. 226)
- 2 poles to relationships – families (protected) & business enterprises (not protected)
 - If group falls in-between – look to factors (size, purpose, policies, selectivity, congeniality, other characteristics)
 - Why don't Jaycees fit w/in “intimate association”?
 - What kinds of groups would fall under this protection?
- Even if group is an “intimate association” it isn't automatically protected – law is okay as long as it isn't an “undue” intrusion
