- b. Specified elements, accounts, or items of a financial statement (paragraphs 9-17).
- c. Compliance with aspects of contractual agreements or regulatory requirements related to audited financial statements (paragraphs 18-19).

"This Statement amends the second sentence of section 410.02 of SAS No. 1 by the addition of the following footpote:

When an ambitior reports on financial statements prepared in accordance with a comprehensive basis of accounting other than generally accepted accounting principles, the first standard of reporting is assisted by disclosing in the auditor's report that the statements are not introduct to conform with generally accepted accounting principles and by expressing an equinon (or disclaiming an opinion) on whether the financial statements are presented in conformity with the comprehensive basis of accounting used (see SAS No. 14, "Special Beyonts," paragraphs through 6).

This Statement also amends section 518.00 of SAS No. 1, to read as follows:

Negative assurances also are permissible in special reports relating to (a) the results of applying agreed-upon procedures to and or more specified elements, accounts, or increase of a financial statement and (b) compliance with aspects of contractual agreements or regulatory requirements related to mobile financial statements. (See SAS No. 1-6, "Special Reports," puragraphs 15 through 19.)
