S.N. EISENSTADT, RENÉ LEMARCHAND (eds.), Political Clientelism,

impianto e sistemi politici analizzati, ma che nelle esplicite intenzioni dei curatori si propongono entrambe di studiare il clientelismo come fenomeno macro-societario, nei suoi rapporti cioè con lo Stato da un lato (Clapham), e come modo generale di regolazione dell'accesso alle risorse di una società (Eisenstadt). L'approccio è quindi, nei saggi caratterizzanti delle due raccolte, molto diverso — più teorico, profondo, ambizioso — della maggior parte di studi nella letteratura, che trattano generalmente del fenomeno clientelare più in modo descrittivo che teorico, più come forma di associazione diadica che di sistema, insomma più come pratica sociale che come struttura sociale. In questo quadro si staglia nettamente il contributo di Eisenstadt-Roniger (nel volume Eisenstadt-Lemarchand), che mi sembra uno dei più importanti tentativi di fondare una teoria del clientelismo come struttura sociale specifica, a metà strada fra sistemi puramente ascrittivi (parentela, sistemi castali) e sistemi burocratico-universalistici.

Il volume Eisenstadt-Lemarchand si articola intorno alla chiara introduzione di Lemarchand e al saggio conclusivo di Eisenstadt, è comprende sia saggi relativi a sistemi politici europei (Italia, Francia e Polonia), che saggi su paesi del Terzo Mondo (Messico, Perù, Turchia). Nel complesso, la parte dedicata al contesto europeo mi sembra migliore degli studi dedicati ai paesi non europei, con la parziale eccezione dello studio di Susan/Kaufman Purcell sul Messico. Il volume di Clapham è quasi interamente dedicato a sistemi extra-europei, salvo un saggio di M.D. Higgins sull'Irlanda e uno di
