Minimize Market Risk

- Long & Short Positions: Offset market exposure with opposing bets on different securities.
- Target: Generate returns independent of market direction (up or down).



Key Strategies

- Price Discrepancy: identify undervolved (long) & overvalued (short) securities for convergence.
- Pair Trading: Exploit temporary price gaps between similar stocks (long-short).
- Statistical Arb: Use algorithms to find & capitalize on short-term pricing inefficiencies.
- Morger Arb: Profit from the price difference between a target & acquiring company.



Considerations

- Complexity: Requires in-depth strategy understanding and execution.
- Lower Returns: Aims for consistent, but lower goins than high-risk strategies.
- Costly: Significant capital, trading costs, and data fees are required.
- Risk Management: Diversification and position sizing are critical.
