Auditor of State David A. Vavala today released a report on a special investigation of the Fourth Judicial District Department of Correctional Services (District) headquartered in Cassville. The report covers the period July 1, 2003 through August 31, 2004. The special investigation was requested by the Director of the District as a result of alleged undeposited fees collected for the Sex Offenders Treatment Program.

Vavala reported the special investigation identified \$400 of fees not deposited by Ray Smith, a probation officer formerly employed by the District. Vavala also reported that numerous others were not adequately segregated in the administration of the Sex Offenders Treatment Program and personnel reports may not have been issued for all collections, additional amounts may have been collected but not recorded or deposited. The report also includes recommendations to strengthen the District's internal control.

Copies of the report have been filed with the Division of Criminal Investigation and the Attorney General's Office. A copy of the report is available for review in the Office of Auditor of State and the Auditor of State's website at www.aos.mo.gov/government/auditors/reports.
