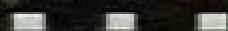

The book is divided into ten chapters. Chapter 1 is introductory while Chapters 2 and 3 discuss the origin and development of law of copyright at international as well as national level. The most important debatable issue in copyright law is works in which copyright subsists and the Chapter 4 is devoted to this aspect. Chapter 5 explores various issues relating to author of work owner of copyright and recognised rights of copyright owner. The terms of copyright licensing of copyright international copyright and registration of copyright are the subject matter of Chapter 6 while rights of broadcasting organisation and of performers neighbouring rights are the subject matter of Chapter 7.
