Equity



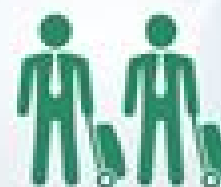
Asia's equity portfolio investment in the region accounts for **19%** of total in 2016, up from 12% in 2001.
