during the conflict at the Paris Peace Conference of 1919 and en poste in Persia and Germany throughout the 1920s Nicolson was ideally placed to observe the maelstrom of international politics As an anti appeasement and wartime MP 1935-1945 he became a highly regarded authority on international relations During and after World War II he turned his mind to the issues of European integration world government and the ultimate possibility of global peace Nicolson has been the subject of two fine biographies This is the first study of his contribution to international thought He emerges from it as an important international thinker alongside theorists as diverse as E H Carr and Leonard Woolf Nicolson's international thought contains elements of realism and idealism while retaining a distinctive character and a breadth and consistency that render it unique
