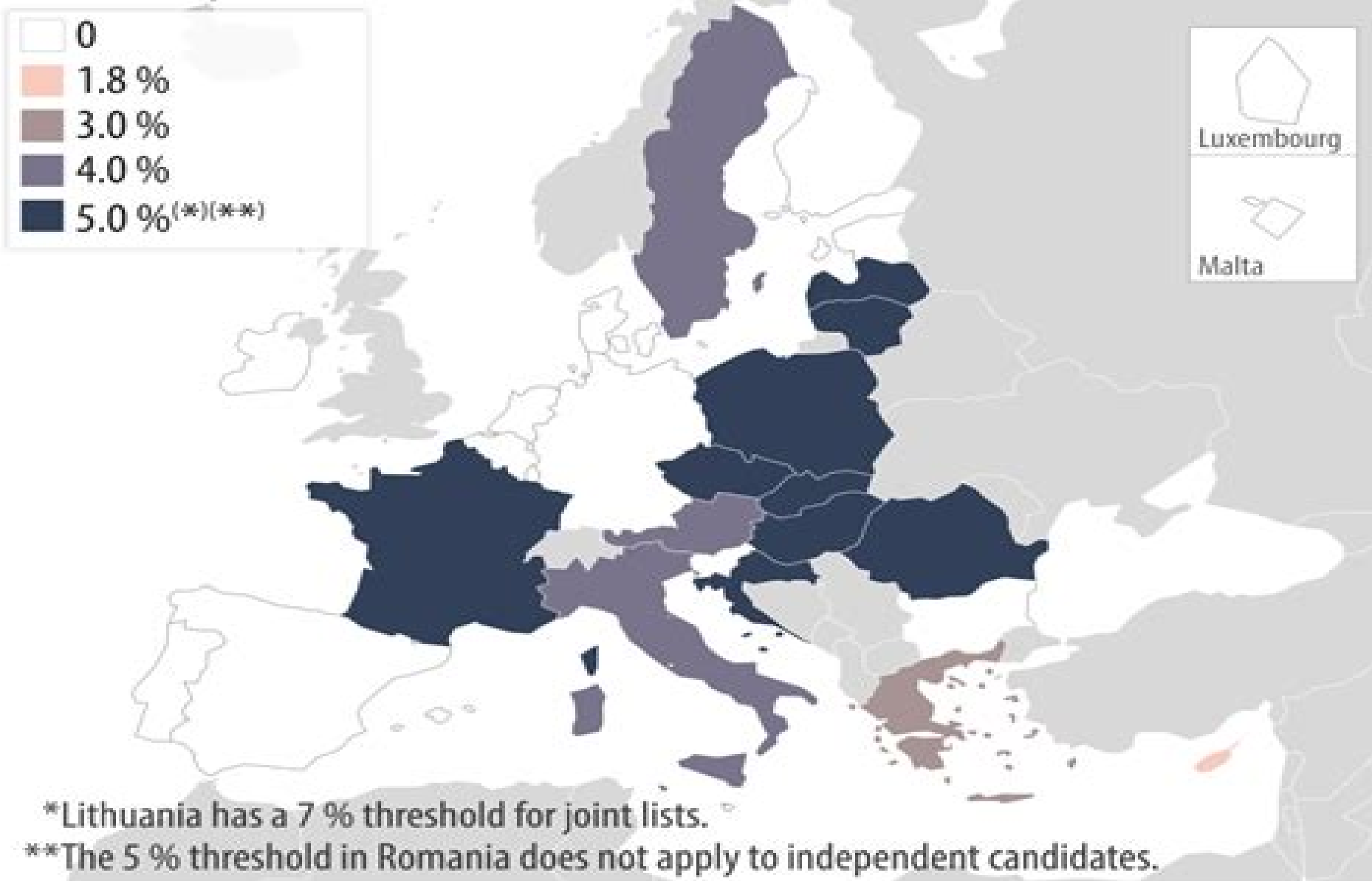


## Election thresholds for the 2024 European elections (as of May 2023)
