The book argues that UK regulators pursued more stringent regulation when they had strong political support to resist financial industry lobbying. UK regulators promoted international harmonisation of rules when this protected the competitiveness of industry or enabled cross border externalities to be managed more effectively but were often more resistant to new EU rules when these threatened UK interests. Consequently the UK was more successful at shaping international standards by leveraging its market power regulatory capacity and alliance building with the US. But it often met with greater political resistance at the EU level forcing it to use legal challenges to block reform or secure exemptions. The book concludes that political and regulatory pressure was pivotal in defining the UK's hard Brexit position and so the future UK EU relationship in finance will most likely be based on a framework of regulatory equivalence.
