In a regime of limited liability the shareholders of the firm have the option to default on the firm's debt Equity can be viewed as a European call option on the firm s assets with a strike price equal to the face value of the firm s debt Actually CCA can be used to value all the components of the firm s liabilities equity warrants debt contingent convertible debt guarantees etc In the four volumes we present the major academic research on CCA in corporate finance starting from 1973 with seminal papers of Black and Scholes 1973 and Merton 1973 1974 Volume I covers the foundation of CCA and contributions on equity valuation Volume II
