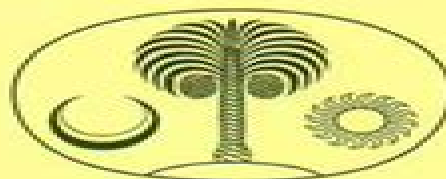

The present third edition of the book has therefore been revised and three chapters at the end have been completely rewritten.
