

From the above discussion, it can be seen that the bills of sales facilitate the individuals to use the goods or property which they own, as security for loans or other types of obligations, while simultaneously retaining possession of these goods. This in turn enable the individuals to efficiently use their goods as and when required³. There lies significant economic rationale and notions behind the implementation of the Bills of Sale Act, which can be described with the help of the theoretical and conceptual frameworks of economics, discussed as follows:

Efficiency in Resource Allocations

In the conceptual framework of economics, one of the primary problems which any economy deals with is that of efficient allocation of resources. One of the primary assumptions in economics is that of the scarcity of resources- that is, all the productive resources are limited and therefore, often trade-offs arise regarding the allocation of resources in such a way that the economic growth as well as the overall welfare is maximized⁴.

In this context, the bills of sale, by enabling the individuals to use their owned products as security for the purpose of procuring loans, while still retaining possession of the same, helps to a considerable extent in efficient allocation and utilization of productive resources (as the goods which are usually used as security for obtaining loans generally fall under the segmentation of capital goods, thereby being one of the four crucial factors of production in economics), thereby helping in increasing the overall welfare of the economy as well as that of the individuals in particular⁵.
