This book, produced as a result of an international collaboration between researchers in Eastern Europe, Africa, the Middle East, Northern Ireland, and elsewhere, aims to provide a guide to the issues faced by researchers working in violently divided contexts. Document the insights and practice wisdom of practising researchers operating in such contexts. Afford access to the lived experience of those researchers and the ethical and methodological challenges which face them. Present accounts and analysis which illustrate a wide range of diverse experiences and perspectives on the experience of doing research in violently divided societies. Chapters cover the role and function of research in divided societies in Africa, the efficacy of research in Northern Ireland, dilemmas of identification and ethnography, research by insiders and outsiders, research for empowerment in Cambodia, the role of research in managing conflicts in Nigeria, researching ethnic conflict in Post-Soviet central Asia, a first-time researcher's experience in Bosnia, the ethics of psychiatric research in war zones, and a final comparison of policy.
