privately For resolution outcome we find that firms with greater liquidity more secured debt and lower cumulative abnormal returns are more likely to be liquidated rather than reorganized And firms with more leverage more intangible assets and filing a prepackaged bankruptcy are more likely to be reorganized Model performance is assessed on the dimensions of discriminatory power predictive and classification accuracy The former two are measured by implementing standard tests power curve analysis and chi squared tests while classification accuracy is assessed according to alternative categorization criteria expected cost of misclassification minimization of total misclassification and deviation from historical averages as compared to nayacute ve random benchmarks While in and out of sample performance along these dimensions exhibits wide variation across models and criteria the OLR and LRM models are found to perform comparably while the FNN model is found to consistently underperform The statistical significance of these results is rigorously analyzed and confirmed through a resampling procedure yielding estimated sampling distributions of the performance statistics confirming these observations
