Interpretation which illustrates Marx's value theory across periods and identifies a tendency towards falling profit rates It is claimed that falling profits in turn are an underlying driver of the systemic propensity towards financialisation crisis and stagnation The empirical findings presented taken from case studies of the UK and Germany appear to support this view The central argument is that the response of agents including the state to the profit tendency has been a significant driver of the observed financial transformation The book then concludes that this synthesis provides a more appropriate explanation of the historical transformation of the financial system since the Great Depression than much of the financialization literature and illustrates the source and operation of financial power in the modern capitalist state and market
