by courts This book therefore critically analyses the policies and regulations in place by mainly comparing the Brazilian framework to the European one This choice has been motivated by the fact that European liberalisation is considered the best so far and as Brazil is starting this process much later it could benefit from the European experience This book will be of particular interest to scholars and practitioners interested in the Brazilian system **Markets, Pricing, and Deregulation of Utilities** Michael A.
