Next, the broader issue is discussed of whether U.S. financial markets affect the behavior of U.S. corporate managers, particularly whether they encourage managerial myopia. Without concluding whether such myopia exists, policy options are examined that would make financial markets more conducive to longer term planning, including permitting banks to invest in corporate equity and thus monitor firms as owners as well as creditors.
