- An entity can obtain funds in a financial market in two ways:
  - By issuing debt
  - By issuing equity
- The most common method is the issuance of debt securities such as bonds or mortgages.
- Debt instrument—a contractual agreement by the borrower to pay the holder of the instrument fixed dollar amounts at regular intervals (interest and principal payments) until a specific date, when the final payment is made.
