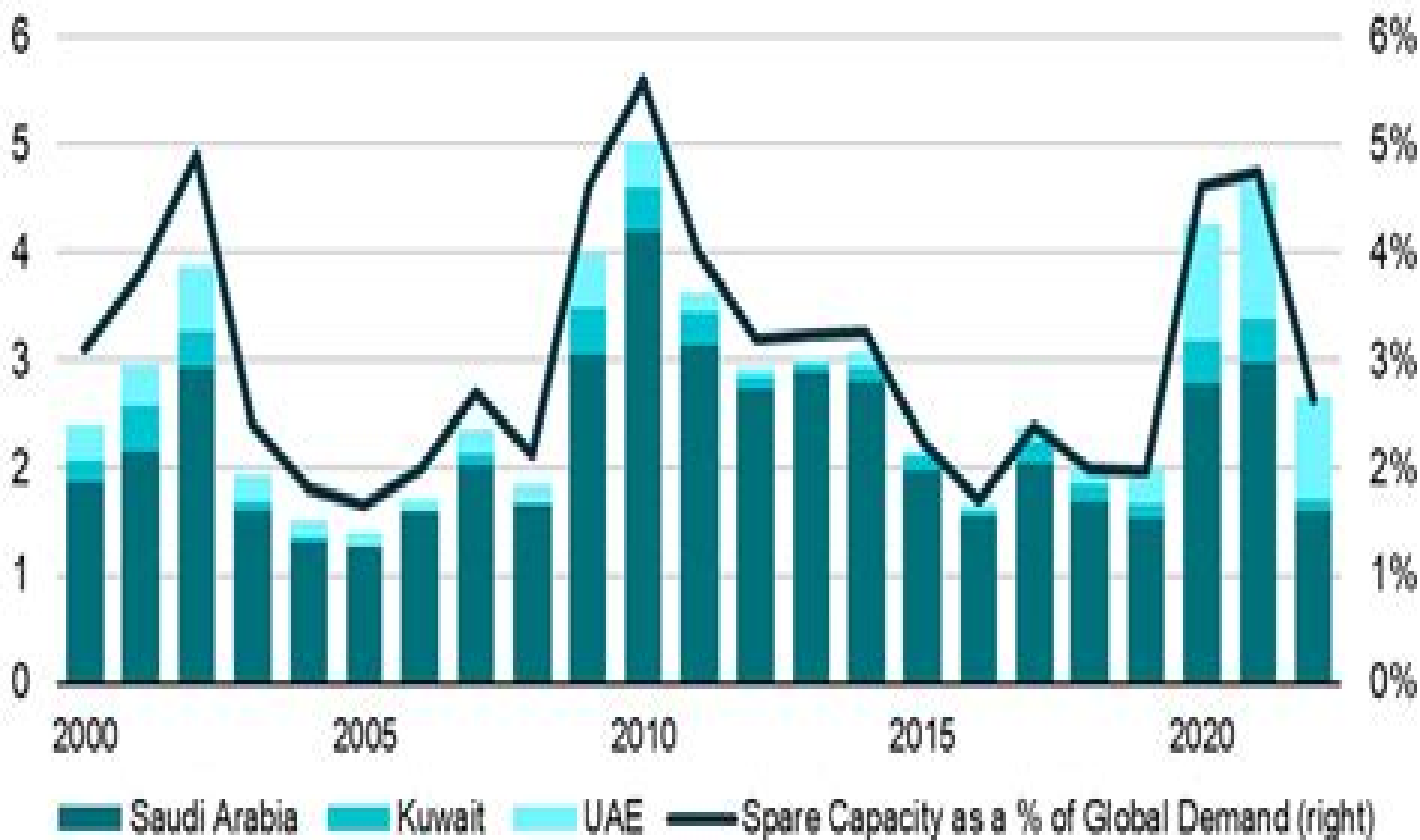


Global Spare Production Capacity
