Section IV deals with some of the procedural issues related to the negotiated settlement of the war. The materials in Section V seek to reappraise the relationship between the constitutional structure of the United States and the way in which the war was conducted while the final section presents the major documents pertaining to the end of American combat involvement in Indochina.
