this stabilising role has on the continental and global positioning of emerging powers In other words this book explores the relation between a country s involvement in conflict resolution initiatives and its positioning in the international system The volume will contribute to this approach using the perspective of academics and practitioners from countries of the Global South particularly from states that have strengthened or sometimes weakened their position in the international hierarchy of power through a leading role in regional conflict resolution initiatives
