Universal Citizenship R. Andrés Guzmán, 2019-01-15 Recently, many critics have questioned the idea of universal citizenship by pointing to the racial class and gendered exclusions on which the notion of universality rests. Rather than jettison the idea of universal citizenship, however, R. Andrés Guzmán builds on these critiques to reaffirm it, especially within the fields of Latino and ethnic studies. These include the French Revolution, responses to Arizona's H.B. 2281, the 2006 immigrant rights protests in the United States, the writings of Oscar Zeta Acosta, Frantz Fanon's account of Algeria's anticolonial struggle, and more. In each case, Guzmán traces the advent of the citizen as a collective subject made up of anyone who seeks to radically transform the organizational coordinates of the place in which she or he lives.
