#### **Diversity**

- Common beliefs: monotheism, divine election, centrality of Toroh, Temple
  - Cultic devotion: related to temples and sacrifice
  - Circumcision
  - Fasting/diet
  - Purity
- But diversity, even in relation to these shared beliefs
- Pharisees: purity concerns for daily life; both written Torah and oral, interpretative traditions about Torah are authoritative
  - · Jesus has controversies with the Pharisees because He is Jewish
- Sadducees: wealthy aristocrats connected with Temple (high priest); Roman corroborators
- Essenes: sectorion group, purity concerns, community discipline; connected with Dead Sea scrolls
- Zeolots: revolutionary group against Roman rule in the 60s; first Jewish revolt (66-73); Jerusalem temple destroyed by Romans in 70
- Samaritans: Israelite descendants; Mt. Geranium; Torah
- If "purity" reflects a concern for the way in which group/community boundaries are maintained and/or the Torah is rightly interpreted then,
  - The Pharisees privatized purity by extending priestly regulations to the home
  - The Zealots politicized purity by engaging in armed conflict with the Roman "outsiders"
  - The Sadducees institutionalized purity in the architectural space of the Temple
  - . The Essenes isolated purity by creating an alternative community
- Early Christianity represented another group within Judaism, known as "the Way" (Acts 9:2, 19:9, 22:4, 24:14 + 22), "the sect of the Nazoreans" (Acts 24:5), or "Christians" (Acts 11:26, 26:28)
  - · How did "the Way" practice purity?
    - Either, the Way internalized purity by making holiness a matter of the heart (ex: Mark 7:1-23)
    - Or, the Way replaced the paradigm of holiness (purity) with a paradigm of compassion/mercy/justice (ex: Luke 6:36)
- Messianic Expectations
  - Messiah is the English of the Hebrew word for "anointed one." In the Old
    Testament, the term most commonly refers to kings and high priests who have
    been anointed by God to serve a certain role. When the Hebrew Scriptures were
    translated into Greek, the translators used the Greek term christos.
  - Between the writing of the Old and New Testaments, the term messioh/christ begins to appear in some Jewish texts to refer to a (usually royal) figure who would act on behalf of or in tandem with God's decisive, end-time action
