<b>Why is this patient specifically receiving this medication? (Include the action of medication)</b> Labetalol is in a class of medications called beta blockers. It works by relaxing blood vessels and slowing heart rate to improve blood flow and decrease blood pressure.		
<b>Side effects/Adverse reactions:</b> CNS: Bradycardia, Hypotensive, fatigue, weakness, anxiety, depression, dizziness, drowsiness, insomnia, GI: constipation, diarrhea, nausea, hyperglycemia, hypoglycemia.		
<b>Lab Values pertinent to administration of medication &amp; RATIONALE:</b> Those with <b>bradycardia (HR &lt; 60 bpm)</b> or systolic blood pressure ( <b>SBP &lt; 100 mmHg</b> ) should avoid using beta blockers. Further decreasing heart rate can lead to serious hypotension and risk of low blood perfusion (SimpleNursing, 2022).		
<b>CONTRAINDICATIONS:</b> Asthma or obstructive airway disease, severe bradycardia, Hypotension with or without syncope may occur. Other medications that lower the HR such as antidepressants.		
<b>Nutritional Considerations:</b> Report symptoms of increased arrhythmias, palpitations, chest discomfort, shortness of breath, fainting, fatigue/weakness. Check for signs of edema, dyspnea, crackles in the lungs.		
<b>HERBAL ALERT:</b> <u>No herbals have been.</u>		
<b>Nursing Implications/Responsibilities</b> Nurses should check for hypotension in a patient and hold the medication if the systolic blood pressure is below 100 mmHg and the heart rate is below 60 bpm. The Nurse must also watch for adverse side effects when given a Betablocker and always check the blood pressure before and after giving the medication. The patients health history is important to make sure there are no contraindications such as asthma and CHF. It is also important to monitor the patient at risk for falls in diabetic patients due to orthostatic hypotension and Hypoglycemia masking effect.
