Rights of the Occupying Power

- can change the laws and regulations in force to the extent necessary (Art. 64, GC IV):
 - to permit it to fulfill its obligations under GC IV
 - to enable it to administer the territory
 - for its own security
- can hand over those accused of violating such laws and regulations to its own military courts in the occupied territory (Art. 66, GC IV)
- can intern the civilian population "for imperative reasons of security" (Art. 78, GC IV)
- can force the civilian population to work...but only in limited circumstances (Art. 51, GC IV)
