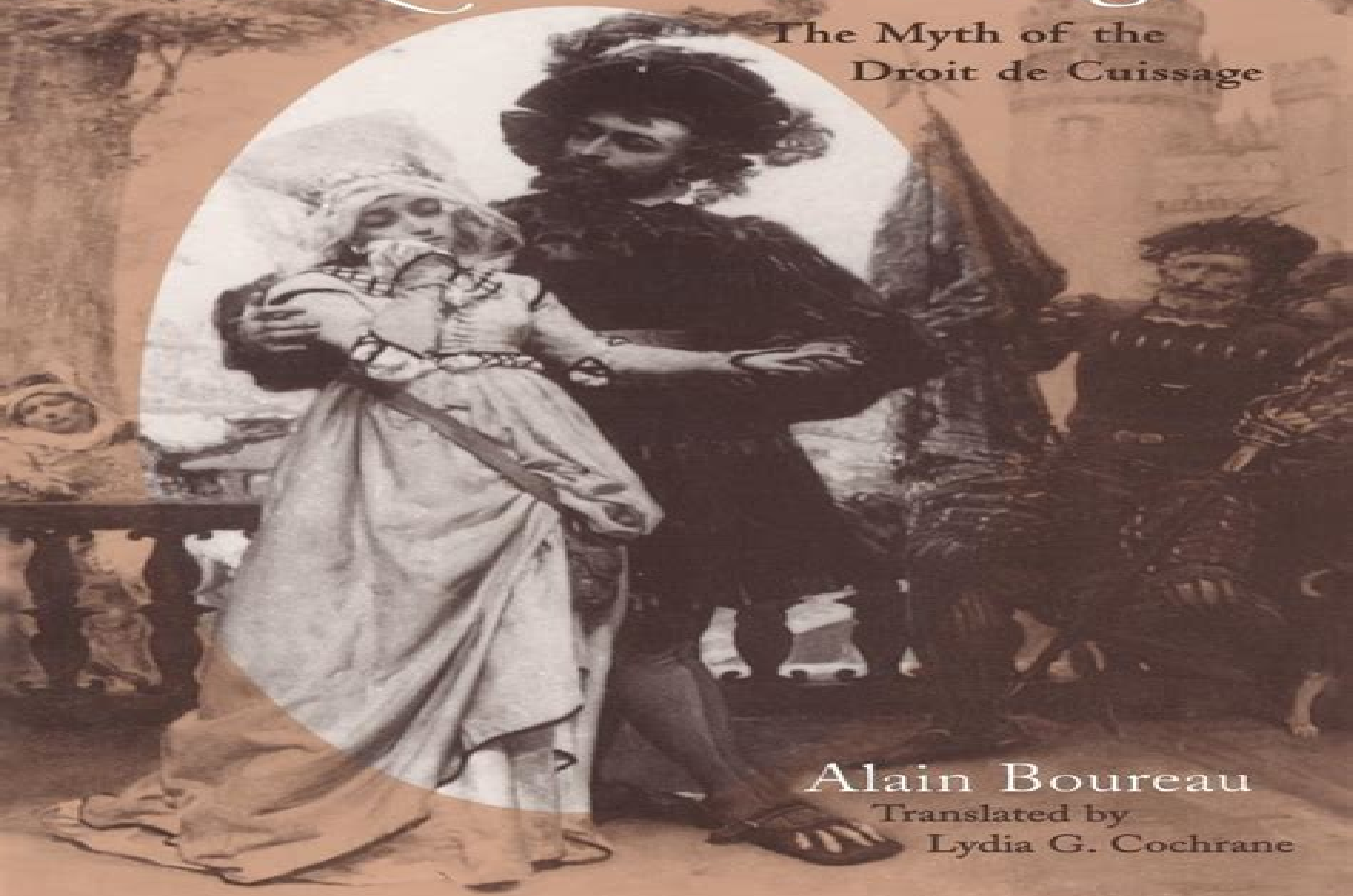

Miller, Edward Wheatley, 2017-01-12 This book of eleven essays by an international group of scholars in medieval studies honors the work of Barbara H Rosenwein Professor emerita of History at Loyola University Chicago Part I Emotions and Communities comprises six essays that make use of Rosenwein's well known and widely influential work on the history of emotions and what Rosenwein has called emotional communities These essays employ a wide variety of source material such as chronicles monastic records painting music theory and religious practice to elucidate emotional commonalities among the medieval people who experienced them The five essays in Part II Communities and Difference explore different kinds of communities and have difference as their primary theme difference between the poor and the unfree between power as wielded by rulers or the clergy between the western Mediterranean region and the rest of Europe and between a supposedly great king and lesser ones *An Analysis of Lucien Febvre's The Problem of Unbelief in the 16th Century* Joseph Tandler, 2018-02-21 Febvre asked this core question in *The Problem of Unbelief* Could sixteenth century people hold religious views that were not those of official Church sanctioned Christianity or could they simply not believe at all The answer informed a wider debate on modern history particularly modern French history Did the religious attitudes of the Enlightenment and the twentieth century notably secularism and atheism first take root in the sixteenth century Could the spirit of scientific and rational inquiry of the twentieth century have begun with the rejection of God and Christianity by men such as Rabelais writing in his allegorical novel *Gargantua and Pantagruel* the work most often cited as a proto atheist text prior to Febvre's study The debate hinged on some key differences of interpretation Was Rabelais mocking the structures of the Christian Church in which case he might be anticlerical Was he mocking the Bible scriptures or Church doctrines in which case he might be anti Christian Or was he mocking the very idea of God's existence in which case he might be an atheist The other great contribution that Febvre made to the study of history can be found not so much in the fine detail of this work as in the additions that he made to the historian's toolkit In this sense Febvre was highly creative indeed it can be argued that he ranks among the most creative of all historians He sought to move the study of history itself beyond its traditional focus on documentary records arguing instead that close analysis of language could open up a gateway into the ways in which people actually thought and to their subconscious minds This concept the focus on mentalities is core to the hugely influential approach of the *Annales* group of historians and it enabled a switch in the focus of much historical inquiry away from the study of elites and their deeds and towards new forms of broader social history Febvre also used techniques and models drawn from anthropology and sociology to create new ways of framing and answering questions further extending the range of problems that could be addressed by historians Working together with colleagues such as Marc Bloch his understanding of what constituted evidence and of the meanings that could be attributed to it radically redefined what history is and what it should aspire to be [The Jacquerie of 1358](#) Justine Firnhaber-Baker, 2021-04-28 The Jacquerie of

1358 is one of the most famous and mysterious peasant uprisings of the Middle Ages Beginning in a small village but eventually overrunning most of northern France the Jacquerie rebels destroyed noble castles and killed dozens of noblemen before being put down in a bloody wave of suppression The revolt occurred in the wake of the Black Death and during the Hundred Years War and it was closely connected to a rebellion in Paris against the French crown The Jacquerie of 1358 resolves long standing controversies about whether the revolt was just an irrational explosion of peasant hatred or simply an extension of the Parisian revolt It shows that these opposing conclusions are based on the illusory assumption that the revolt was a united movement with a single goal In fact the Jacquerie has to be understood as a constellation of many events that evolved over time It involved thousands of people who understood what they were doing in different and changing ways The story of the Jacquerie is about how individuals and communities navigated their specific political social and military dilemmas how they reacted to events as they unfolded and how they chose to remember or to forget in its aftermath The Jacquerie of 1358 rewrites the narrative of this tumultuous period and gives special attention to how violence and social relationships were harnessed to mobilize popular rebellion
