- Have all students stand up and predict each answer with whiteboards, or "signing" the answer, or by raising left hand for true, right hand for false, etc.). Students who get it correct get to remain standing. Incorrect answers sit down. Last student standing wins!
- Ask students to come up with their own set of Fact or Fiction at the end of the unit to quiz each other.
