

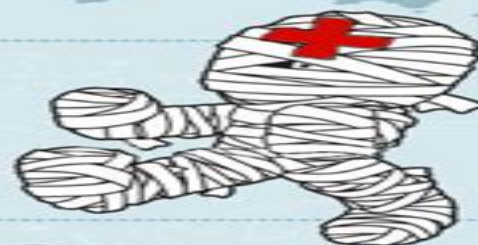

3000 B.C. EGYPT

FIRST ORGANIZED HEALTHCARE

Ancient Egyptians develop the first organized system of healthcare, including maintaining medical records and classifying drugs.



380 A.D. ROME

SAINT FABIOLA OF ROME

Saint Fabiola of Rome dedicates herself to the service of the poor and opens the first hospitals to offer nursing and surgical care to the masses.

1860 CRIMEA



Florence Nightingale revolutionizes infection control during the Crimean War and forever changes the face of the once male-dominated nursing profession.

1940 WWII

Military nurses are temporarily assigned officer's rank during WWII in a show of respect and appreciation.

EARLY 1960'S

The term **"NURSE PRACTITIONER"** begins being used to describe the many nurses serving in primary care roles in response to a national shortage of healthcare services.

1965 UNIVERSITY OF COLORADO

Visionary nurse educator, Loretta Ford, partners with a pediatric physician to develop the first formal post graduate certificate program for nurse practitioners. Universities around the country would develop sixty-five new programs over the next 9 years.

1971

The US Secretary of Health, Education, and Welfare makes a formal recommendation stating that NPs are qualified to serve as primary care providers.

MID 1970S - EARLY 1980S

National certifying agencies begin playing a more active role in preparing NPs, establishing master's degrees as the educational qualification needed to become a Certified Nurse Practitioner.

BY THE LATE 1980'S

More than \$100 million in government funds have been allocated to educational grants for NPs.

1997

Congress grants approval for nurse practitioners to receive direct Medicaid and Medicare reimbursement for healthcare services.

LATE 1990'S - MID 2000'S

Nurse practitioners become an established part of the medical community, with an estimated 106,000 NPs in practice by 2004.

2008

The APRN Consensus Model is developed and defines the NP scope of practice to include independent practice and prescriptive authority. Twenty-four state Boards of Nursing adopt a similar definition.

2012

Discussion is ongoing among education accreditation agencies, national certifying bodies, and state boards of nursing about establishing the DNP as the new educational minimum for NP certification and licensure by 2015.
