

Patient participation as discursive practice—A critical discourse analysis of Danish mental healthcare

Patient participation is one of the most prevalent focus areas in the Danish healthcare debate. Patient participation is generally presented as a fundamental democratic right, and is stated in an objective language with legal requirements for healthcare professionals to ensure that patients systematically participate in their own courses of care and treatment. In the research literature, it is not clear what is meant by 'patient participation', and several discourses on patient participation exist side by side. This study explores how discourses of patient participation unfold and are at play in the articulations in official legal and political documents and patient records relating to a Danish psychiatric context. The documents and patient records have been analyzed using a Fairclough-inspired critical discourse approach which is concerned with how power is exercised through language. The research findings show that patient participation within Danish psychiatric healthcare is governed within a neo-liberal discourse where underlying discourses; discourse of bio-medicine, paternalism, management, evidence and ethics of care are embedded, and a discourse that seems to ascribe stigmatizing traits to mentally ill patients.

1 | INTRODUCTION

This study shows how discourses of patient participation are at play in the language used in official legal and political documents and patient records relating to a Danish psychiatric context. In Denmark, like other Western countries, patient participation is one of the most prevalent focus areas in the healthcare debate. Patient participation is presented as a fundamental democratic right and is stated within legal requirements for healthcare professionals to ensure that patients systematically participate in their

course of care and treatment from start to finish (Holen, 2015; Vrangbæk & Christensen, 2005). Generally, in the debate, patient participation is articulated as something positive, which is substantiated by the factual claim that it improves quality of life and provides an increased sense of ownership and management of one's symptoms, illness and circumstances, and gives people a sense of control and self-determination. It is also claimed that patient participation improves treatment processes (Sahlsten, Larsson, Undenios, & Plos, 2005), quality of care (Castro, Regenstein, Vanhaecht, Sermeus, & Heide, 2015; Coulter & Ellis, 2007) and leads to more effective services—implying reduced costs (Dietz & Eide, 2009). Last but not least, it is argued that patient participation reduces adverse incidents, as the patient becomes an owner of their own care, taking precautionary measures against flaws in a hectic healthcare system (Storm & Davidson, 2010).

In this study, we focus on mental healthcare partly due to the realization that people with psychiatric illness in general constitute a marginalized and neglected group in healthcare policy, management and wider society (Jacobsen, Martin, Andersen, Christensen, & Bengtsson,
