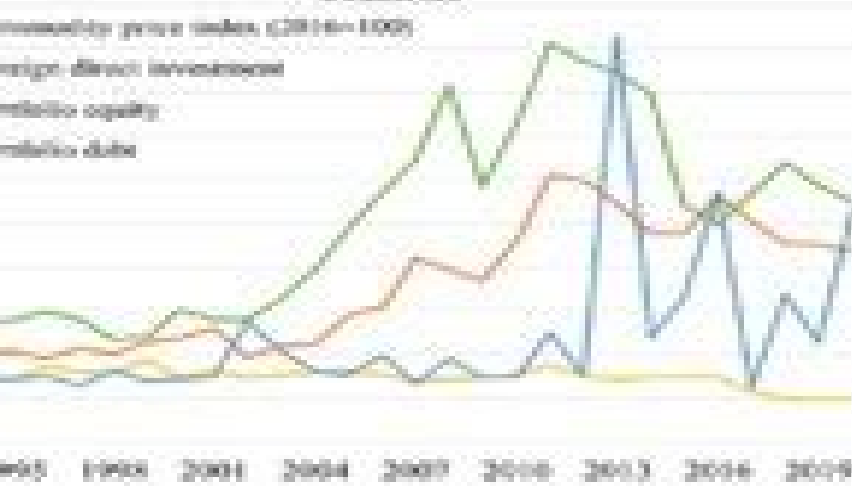


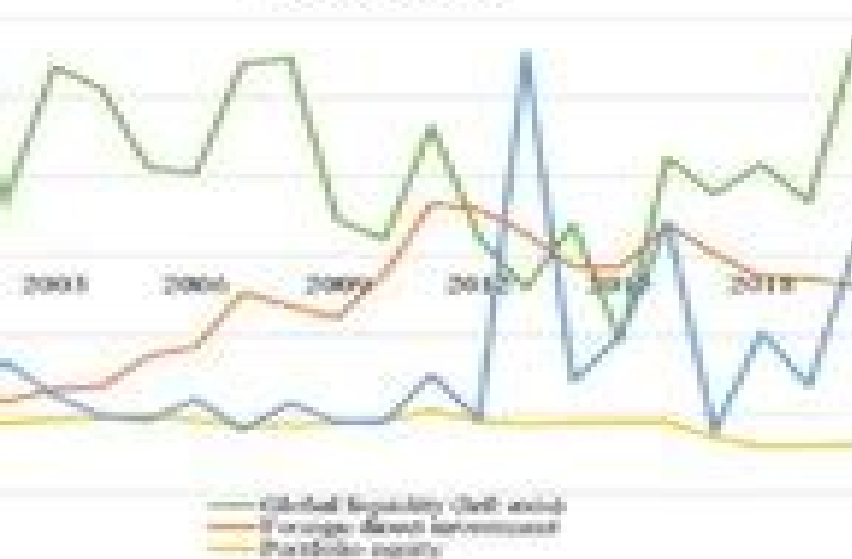
Commodity Prices and Capital Inflows to Low-Income SSA Countries



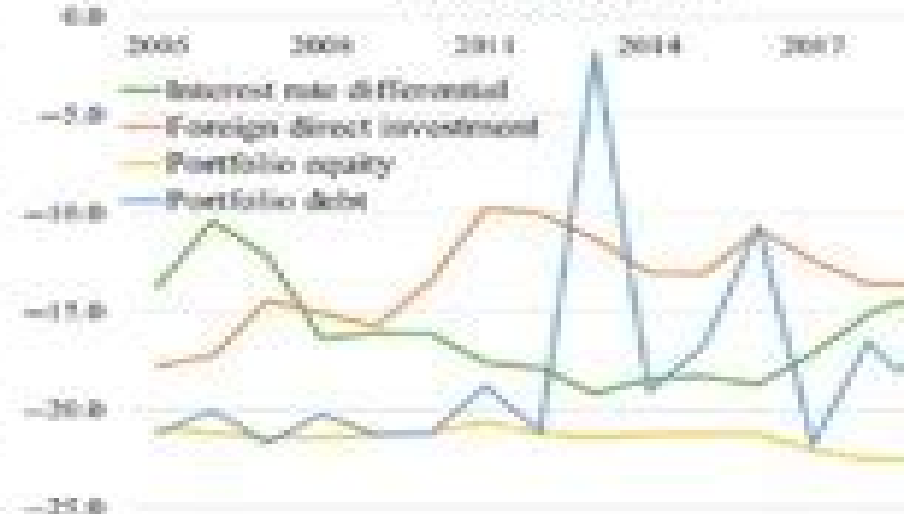
VIX and Capital Inflows to Low-Income SSA countries
