Establishing that a counterparty is in breach of contract is only the first hurdle to obtaining proper redress. Otherwise, the innocent party is likely to be awarded only nominal damages and may even be required to pay legal costs.







Julian Copernan, Natasha Johnson and Rachel Lidgate consider the principal remedies available for breach of contract, focusing in particular on damages and how they are assessed, and provide some practical tips.
