Good strong singing voices are, of course, a plus for several roles, but not mandatory for casting all roles. Above all, we are hoping for players who can work together in a true ensemble format and have fun with the playful imaginative stagecraft.

While some characters are considered 'leads', this is a show where we will be working together from the very first rehearsal through all the performances. All actors, regardless of what part they are cast in, will be involved in moving sets and playing multiple parts in the production.

A lonely and hardened orphan who doesn't miss much, Peter is nameless, homeless, and friendless at the beginning of the play, and a hero by the end.
