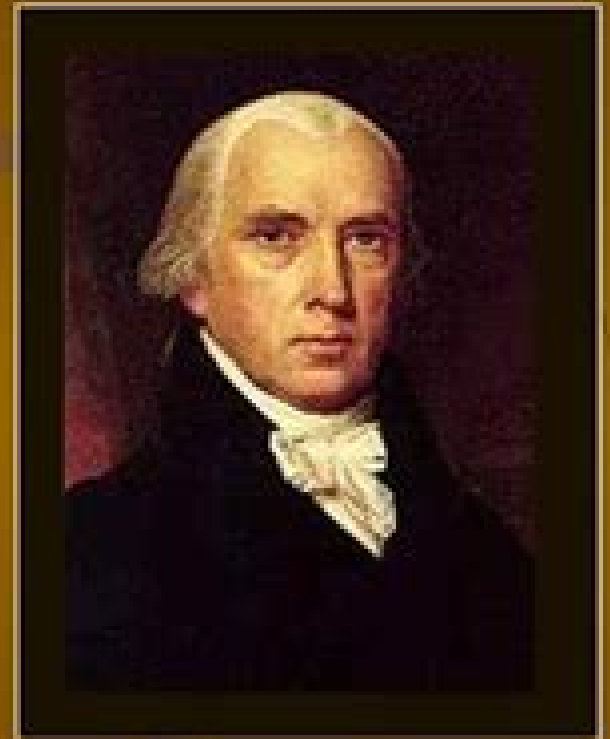
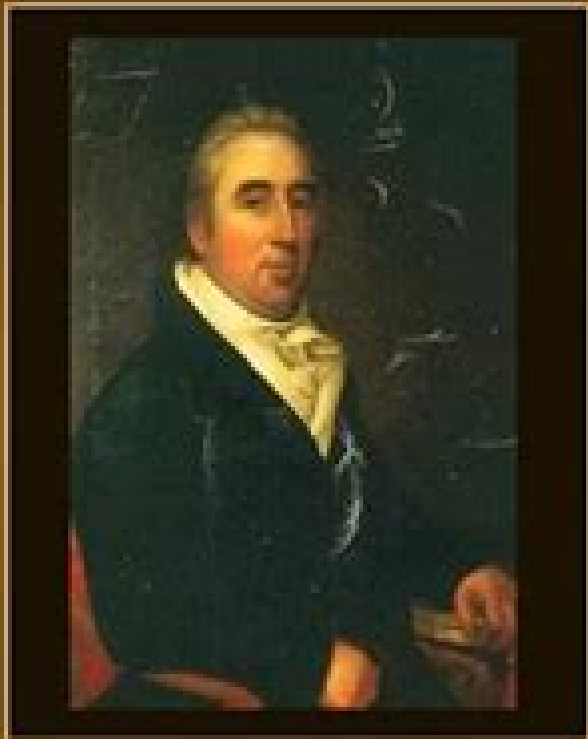

Marbury v. Madison William E.
