a particular market's efficiency In response to the 2007-2009 financial crisis the 2010 Dodd-Frank Wall Street Reform and Consumer Protection Act (Dodd-Frank P.L. 111-203) established the Bureau of Consumer Financial Protection (CFPB) to implement and enforce federal consumer financial law while ensuring consumers can access financial products and services. The CFPB's authorities fall into three broad categories: rulemaking (writing regulations to implement laws under its jurisdiction), supervision (the power to examine and impose reporting requirements on financial institutions), and enforcement (of various consumer protection laws and regulations). The CFPB generally has regulatory authority over providers of an array of consumer financial products and services. The major consumer financial markets include mortgage lending, student loans, automobile loans, credit cards, and payments (payday loans and other credit alternatives), financial products, and checking accounts and substitutes. In addition, two important market structures allow these consumer financial products to be offered: 1) the consumer credit reporting system, and 2) the debt collection market. These aspects of the consumer credit system facilitate the pricing of credit offers and the resolution of delinquent consumer credit products for most consumer credit markets.
