study is broken out by the level of student undergraduate masters doctorate medical professional and by function of the University It was found that all levels of education have a positive return not only for the individual but also for the State Treasury This is in excess of any non pecuniary benefits to the State of having a better educated population or the local taxation effects on the county or city where the campus is located These returns are found to be higher than other types of investments
