(1962)**

Federal courts have jurisdiction to consider constitutional challenges to state legislative redistricting plans.

**Reynolds
v. Sims
(1964)**

Apportioned substantially according to population.

Exception from strict population equality to give representation to minorities and create compact districts of contiguous territory.

Districts should be redrawn at least every 10 years.

**Miller v.
Johnson
(1995)**

A district becomes an unconstitutional racial gerrymander if race was the "predominant" factor in the drawing of its lines.

eliminate competition and are built to be resistant to electoral tides will be struck down Court intervention to end egregious partisan gerrymandering is necessary for a number of reasons
