market integration as the relative price of foreign goods falls and households increase their consumption of imported goods. In addition, with more market integration, the model predicts that the variability of the real exchange rate should fall while the variability of the trade balance should increase. Trade costs have ambiguous effects on the volatility of other macro variables such as income and consumption. Finally, we present some empirical findings that provide mixed support for the model's predictions.
