**Liberation by Oppression** Thomas Szasz, 2017-09-29 Originally called mad doctoring psychiatry began in the seventeenth century with the establishing of madhouses and the legal empowering of doctors to incarcerate persons denominated as insane Until the end of the nineteenth century every relationship between psychiatrist and patient was based on domination and coercion as between master and slave Psychiatry its emblem the state mental hospital was a part of the public sphere the sphere of coercion The advent of private psychotherapy at the end of the nineteenth century split
