conflicting state laws it precluded state governments from violating U S treaty obligations Before 1945 treaty supremacy and self execution were independent doctrines Supremacy governed the relationship between treaties and state law Self execution governed the division of power over treaty implementation between Congress and the President In 1945 the U S ratified the UN Charter which obligates nations to promote human rights for all without distinction as to race In 1950 a California court applied the Charter s human rights provisions and the traditional treaty supremacy rule to invalidate a state law that discriminated against Japanese nationals The implications were shocking the decision implied that the United States had effectively abrogated Jim Crow laws throughout the South by ratifying the UN Charter In response conservatives mobilized support for a constitutional amendment known as the Bricker Amendment to abolish the treaty supremacy rule The amendment never passed but Bricker s supporters achieved their goals through de facto constitutional change The de facto Bricker Amendment created a novel exception to the treaty supremacy rule for non self executing NSE treaties The exception permits state governments to violate NSE treaties without authorization from the federal political branches The death of treaty supremacy has significant implications for U S foreign policy and for U S compliance with its treaty obligations
