Real Options Valuation Marcus Schulmerich, 2005-12-08 Managerial decision making during the lifetime of a project can have important implications on project handling and its contribution to shareholder value Traditional capital budgeting methods in particular methods based on net present value fail to capture the role of managerial degrees of freedom and therefore tend to lead to a systematic undervaluation of the project In contrast the real options approach to investment analysis characterizes decision making flexibility in terms of real option rights which can be evaluated analogously to financial options using contingent claims pricing techniques widely used in capital markets The research carried out by Marcus Schulmerich analyzes real options for non constant and stochastic interest rates versus constant interest rates Analyzing stochastic interest rates in the context of real options valuation is of particular relevance given their long time to maturity which makes them more vulnerable to interest rate risk than short term financial options To date there has not been a comprehensive review of this issue in the academic literature The fact that interest rates have fluctuated widely over the recent years further highlights the need for studying this issue
