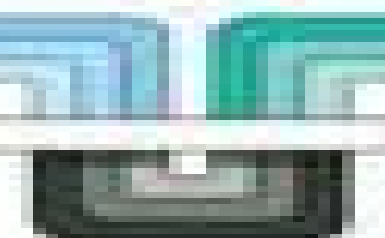

In this study, the author identifies six types of judicial precedent ideology among them: judicial legislation, systemic construction of the underlying reasons of law in the Dworkinian sense, and a radical re-evaluation of the merits of a prior case in later adjudication as envisioned by the American Realists. These competing models are tested against judicial experiences in the UK, US, France, Italy, Germany, and Finland. By this means, Lon Fuller's famous internal morality of law is shown to function rather poorly in the context of precedents, and the author therefore suggests a redefinition of the rule which makes it work for precedent. The author claims that Hart is caught between Kelsen and J. L. Borges, the late Argentinian fabulist, in so far as the ontology and epistemology of the rule of recognition are concerned.
