14.1 OVERVIEW

Contracts in restraint of trade are prima facie void under the common law, but can be enforceable if:

- the party imposing the restraint has a legitimate interest to protect; and
- the restraint is reasonable in the context of protecting that interest; and
- the restraint is not otherwise contrary to the public interest.

The reasonableness of a restraint will be assessed in relation to:

- the length of time for which it will operate;
- the geographical area which it will cover;
- the scope of the restraint (that is, the range of activities covered).

The situations where these rules tend to apply are in relation to:

- contracts of employment – in the form of restrictions on the employment that the employee can undertake once leaving the employment of the party imposing the restraint. Such restrictions may be justified to protect trade secrets, or connections with clients;
- contracts for the sale of a business – the buyer of a business is entitled to impose restraints on the seller, to prevent the seller setting up in competition with the buyer.

Other types of restraint that need consideration are as follows:

- Contracts of exclusive dealing. Agreements to take all supplies of goods (for example, petrol, beer) from one supplier may be enforceable if reasonable.
- Restraints on songwriters and entertainers. This is another type of contract of exclusive dealing, where the artist agrees to work only for one publisher, record company, etc. Such restrictive contracts may be enforceable if they are reasonable.

Trade associations. Agreements between companies not to compete in certain areas will be unenforceable at common law unless reasonable in protecting a
