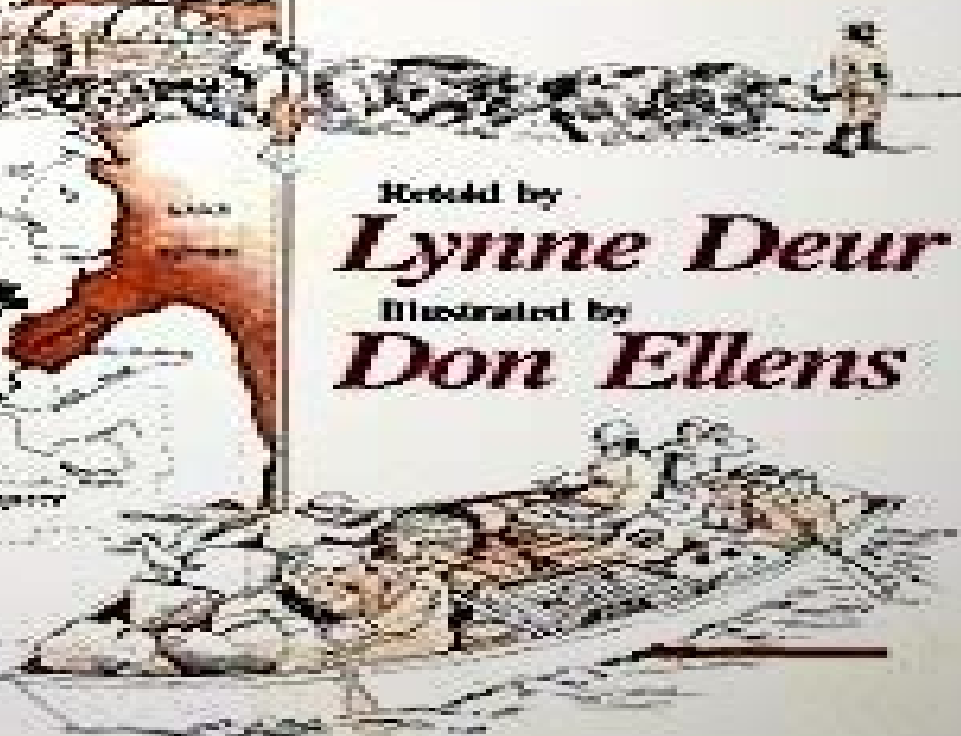

was founded in 1836 the Atherton School was a one room schoolhouse built on the corner of Atherton Trail and Center Road where the Burton Memorial Library sits now Betsey Atherton was the first teacher Throughout my research we have a lot to be thankful for especially the four Atherton men that were brave enough to stay and never give up on the settlement As more people joined the settlement for the next 20 years some had military backgrounds and mostly coming from New York With all manner of trades to prosper as the community when more schools were needed the farmers would build one in each area for the children 1855 Atherton Settlement combined with other farms to become Burton Township the second largest township but without a post office so HIDDEN **History of Ottawa County, Michigan ,1882 Economic and Social**
