The first list called the Drinking Water Contaminant Candidate List CCL was published in March 1998 The main function of the CCL is to provide the basis for deciding whether to regulate at least five new contaminants from the CCL every five years However since additional research and monitoring need to be conducted for most of the contaminants on the 1998 CCL the list is also used to prioritize these related activities Classifying Drinking Water Contaminants for Regulatory Consideration is the third report by the Committee on Dinking Water Contaminants with the purpose of providing advice regarding the setting of priorities among drinking water contaminants in order to identify those contaminants that pose the greatest threats to public health
