By focussing on primary prevention, One Welfare principles offer cross-disciplinary solutions to address the common drivers of biodiversity loss and climate change, and mobilise relevant sectors, disciplines and communities to reduce future zoonotic disease risk.

Reducing and eliminating highrisk human activities such as the taking, holding, trade, marketing, use and consumption of both wild and domestic animals that pose a risk to public health are vital to tackle the root causes of zoonotic disease transmission. Such mechanisms and measures to prevent pathogen emergence at source must be incorporated into the new global instrument negotiated under the World Health Organisation.
