

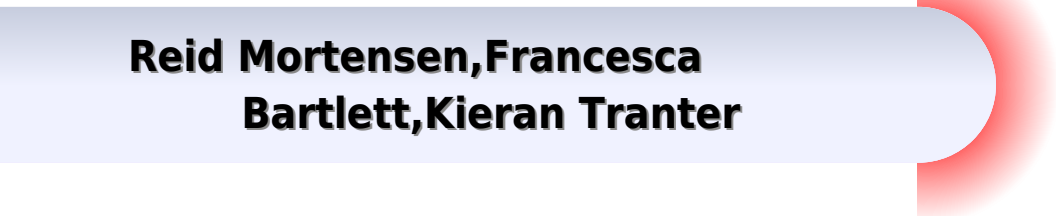


Problems with mediation in legal context

- According the pure model of mediation (facilitative) mediator dominates the mediation process but the parties dominate subject matter of the conflict and the resolution of the conflict
- In legal context (e.g. court - annexed mediation) mediation systems are often in practice hybrid systems; there are activities like evaluation and compromising
- In many western countries judges promote settlement in court process; it is not mediation
- In some countries there are mandatory mediation systems
- In hybrid conflict resolution systems ethical principles of mediation do not realize and on the other hand people get not even formal legal protection; it can be semi-legal system
