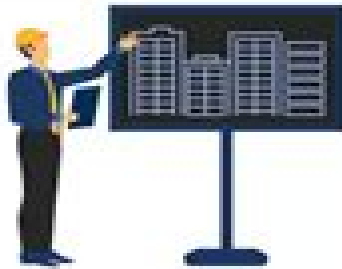


# HOW DOES THE CONSTRUCTION PROCUREMENT PROCESS WORK?
